DRAFT TEXAS ASBESTOS HEALTH PROTECTION RULES AVAILABLE FOR STAKEHOLDER COMMENT

In 2014, the Texas Department of State Health Services (Department) began reviewing the Texas Asbestos Health Protection Rules (TAHPR), 25 Texas Administrative Code §§295.31-295.73. At that time, the Department asked stakeholders for rule recommendations. The Department has prepared <u>draft rules</u> and <u>responses to</u> <u>stakeholder recommendations</u>.

The Department is seeking informal comments on the draft rules from stakeholders. The draft rules will be available for informal public comment until April 28, 2016. The Department will consider each comment received during the informal comment period but will not provide an individual response to each commenter.

Please provide the following for each comment submitted:

- Identify the draft section number.
- Provide language that you recommend.
- Describe how your recommended edit will affect public health and the regulated community.

The Department must adopt rules to administer and enforce the Texas Asbestos Health Protection Act in a manner that is at least as protective of human health and safety as the minimum requirements of the Texas Asbestos Health Protection Act and the federal National Emission Standards for Hazardous Air Pollutants. The Department may not adopt rules that would conflict with or fail to carry out the requirements in applicable federal regulations or state statutes. Copies of the current TAHPR, the Texas Asbestos Health Protection Act, and the federal National Emission Standards for Hazardous Air Pollutants are available on the Department's Asbestos Program website at www.dshs.state.tx.us/asbestos.

The Department will set the draft rules on the agenda for discussion during the May 18, 2016, work session meeting of the State Health Services Council (SHSC). The Department plans to present proposed rules as an action item at the SHSC meeting scheduled for August 18, 2016. If the SHSC votes to recommend publication of the proposed rules and the Executive Commissioner approves, the Department will publish proposed rules in the Texas Register, and a formal 30-day public comment period in fall of 2016 will follow.
